**SIGN UP FOR AUTOMATIC PAYMENT**

Using the bank draft plan you will never have to write a check to pay your utility bill. You will always avoid the 10% late charge. For your convenience, Jointly Owned Natural Gas can set up your account with a bank draft and your bank can make the payments directly from your checking account upon JONG's request.

You will still be mailed your monthly statement at least 15 days before the due date so that you will know the amount of the draft in advance.

Your bank account will be drafted on the Due Date located on your bill each month.

If you have been using the mail to send your payments, you will save postage plus the cost of an envelope and checks. You will also be saving the time and expense of driving to our office to pay your bill. When you go out of town or on vacation, you will not have to worry anymore whether or not you have paid the utility bill.

Please allow at least 30 days from the time you submit your request for draft service for the sign up process to be completed. Sign and return the form below with a voided check and each month in the future, your bank account will be drafted to pay your utility bill until you tell us otherwise.

If you have any questions, please call our office at 478-654-6059. If you are currently on draft and move to another address or would like to add or delete another address, please call or visit our office. To change bank accounts, send in a voided check and advise us in advance of your draft.

“TO BE DRAFTED BEFORE PENALTY DATE” will appear on your bill when the authorization process is complete.

This authorization will remain in effect until I notify JONG that I no longer desire this service, allowing JONG reasonable time to act on my notification.</p> <p>I understand JONG will continue to send me a monthly bill before my bank account is charged and that I have the right to stop a debit by notifying my financial institution at any time up to three (3) banking days before the scheduled date of the debit. I further understand that JONG may impose a processing fee in the event that a debit entry is not paid by my financial institution. For example, JONG may charge me a fee if my account contains insufficient funds to cover a prearranged debit.
